BACKGROUND & ELIGIBILITY REQUIREMENTS

Two (2) scholarships will be awarded to attend the 2014 NAPSA Conference October 29 & 30, 2014 at the Marriott Downtown Waterfront, Portland, Oregon.

The scholarships will be in the amount of \$1350.00; \$350.00 to be deducted for the conference member registration fee and a check for \$1000.00 to be given to the recipient at the end of the conference to put towards travel expenses. Checks will be made out to the person awarded the scholarship unless NAPSA is notified well in advance of the conference that the check is to made out to the person's agency.

NAPSA plans to notify award recipients as soon as possible after the submission deadline.

Scholarships are limited to persons who:

- Are currently employed as an APS caseworker, supervisor or administrator
- Are committed to improving their skills and knowledge in order to better perform their APS responsibilities
- Are committed to sharing the information gained at the NAPSA Conference with their APS and allied professional colleagues when they return to their communities
- Cannot attend the conference without financial support
- · Have the approval of their agency and sufficient other financial support to attend

Preference is given to persons who:

- Are frontline workers/investigators
- Have never before attended a NAPSA Conference
- Write a clear and compelling statement for attending the conference

Applicants that meet eligibility criteria will be reviewed by the NAPSA Scholarships Subcommittee and recipients will be selected based on their application.

Awardees are expected to register for the conference in a timely manner and must have their supervisor's approval to attend the conference prior to completing the application.

This scholarship does not include registration for the 5th Annual Summit on Elder Financial Exploitation Scholarship Recipients who wish to attend this event must pay the additional registration fee.
