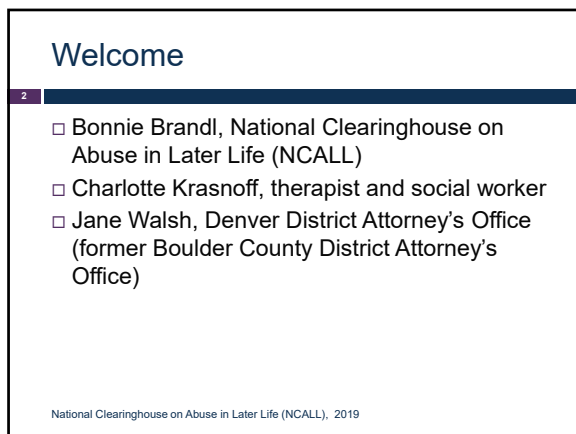

Funded by the Office for Victims of Crime (OVC)
Released for pilot testing

- OVC's role
 - Competitively funded this project in 2017 under its first *Field-Generated Innovations in Addressing Elder Abuse and Financial Exploitation Program* solicitation (one of several national-scope projects funded by OVC under this program)
 - Federal grant-making authority to issue and monitor grants and cooperative agreements under the Victims of Crime Act (VOCA)
 - Once evaluated, draft materials to be finalized and submitted to OVC for final approval and dissemination to the field.
