ZOOM

- Basic cost is free for up to 99 people allows for up to 40 minutes of time
- The Host can record the session safe and share training
- Security for Zoom has been updated and you can control the admission, removal and lock the room
- Zoom.us/live training Monday Friday Free

Turning Point

- Can be in person with use of clickers; much like a black berry for immediate responds or
- Via web Quickly and easily open a web browser for the ability to respond to questions on any web-enabled device or
- Mobile phones Download the Turning Point app on smart phones and tablets for Android and iOS devices
- Very interactive
- Provides for immediate feedback

GoToWebinar Strengths

- Plan options renew either monthly or annually; ranges from \$49-\$399/month.
- Website provides a lot of technical supports/tools.
- Meetings can be scheduled instantly or scheduled for a future day/time.
- GoToWebinar is like attending a conference session; participants can range from 100-2000 people depending on the package.
- Allows for audience interaction (polls, participants can raise their hands, Q&A, and questions can be submitted before or during the event.
- Allows for panelists.
- Handouts can be preloaded (up to 5 handouts each must be less than 100MB).
- Sessions can be recorded and made available on-demand.

GoToWebinar Limitations

- Cost may be prohibitive.
- Some say the platform and interface is dated compared to other products.
- Administrative limitations (i.e. changing session type, bulk upload of participants).
- Presenters may not have access to high-quality technology such as a headset and computer.
- Having an organizer/producer for each live session may be resource-prohibitive.

MICROSOFT TEAMS MEETING AND MICROSOFT TEAMS LIVE EVENTS



Microsoft Teams Meeting

- · Limited to 250 attendees
- Designed for real time collaboration
- · No hierarchy of roles.
- · Can add participants at any time
- · Anonymous users can attend
- Allow up to 4 meetings (main meeting and 3 subgroups)

Microsoft Teams Live Event

- Allows up to 10,000 attendees
- 15 to 60 second delay with little audience participation.
- Multiple roles that dictate access
- Meeting can be set to allow late attendees to view the event from the beginning.
- Download a list of attendees



MICROSOFT TEAMS MEETING AND MICROSOFT TEAMS LIVE EVENTS

Challenges

- Sharing videos
- Quality of Presenter's bandwidth will impact quality of content being shared

Live Events

- switching between presenters can be tricky
- Can only view presenters one at a time

Special Features

Live events

- ability to change the language by attendees can be enabled
- Setting for closed captioning
- Can use external devices (e.g. professional camera setup)
