





Adult protective services (APS) are not a monolith—in which a single APS agency in any state or county can meet the needs of all those that it is charged to protect. Rather, it is a collection of fractured and often siloed entities, who may be unaware that they are serving the same individual with a shared goal. Filmmakers Stu Maddux and Joseph Applebaum will discuss their current project, Heroes of Adult Protection ("HOAP"). HOAP will portray the struggles and triumphs of the APS system nationwide, as exemplified by compelling stories of the glaring cracks in the system—and how the victims, their families, and APS professionals used these circumstances to act as agents of change. Specifically, the presentation will discuss three Massachusetts based cases which led to the formation of new APS models and programs designed to address shortfalls in protections. Please join us to learn about the great changes that started from small conversations and discover how you might use the lessons learned to serve as a catalyst in your state to address the challenges you face.

ELIZABETH D. SCHEIBEL

Elizabeth D. Scheibel is the retired Northwestern District Attorney of Massachusetts. A 30 year career prosecutor, she served for 18 years as district attorney and was the first woman district attorney in the Commonwealth of Massachusetts. As district attorney, Ms. Scheibel emphasized community education and outreach, particularly in the areas of child sexual assault, elder abuse, domestic violence and crimes against persons with a disability.

District Attorney Anthony D. Gulluni was sworn into office as Hampden District Attorney in January 2015, and is currently serving his third four-year term. While in office, District Attorney Gulluni has promoted his vision of safer communities by innovative programs with significant investment in community building and outreach to at-risk and vulnerable populations, crime prevention and education.

Jane F. Ryder has led the Department of Developmental Services (DDS) as Commissioner since February 2018. Jane knows DDS both as Commissioner and as a family member, as her brother Mark receives DDS services. As Commissioner, Jane has led reforms to streamline and rationalize the Adult Long-Term Residential service model and launched the Technology Forward initiative.



CHERYL RYAN CHAN

Cheryl Ryan Chan is a professional public speaker, trainer and facilitator. Cheryl is Mom to Nicky, a young man impacted by profound autism and intellectual disabilities. Cheryl's son is the name behind Nicky's Law/Dana's Law, which established an abuser registry to protect people with disabilities in Massachusetts. The bill was signed into law in 2020.

What is NAPSA?

The National Adult Protective Services Association (NAPSA) is a national non-profit 501 (c) (3) organization with members in all fifty states, DC, and the territories. Formed in 1989, the goal of NAPSA is to provide Adult Protective Services (APS) programs a forum for sharing information, solving problems, and improving the quality of services for older adults and people with disabilities who are victims of abuse, neglect, self-neglect, or financial exploitation.

To fulfill its mission, NAPSA:

- Partners with diverse organizations from law enforcement to financial institutions to provide a cohesive network of research, practice, and policy to meet the diverse needs of the ever-changing population of vulnerable adults.
- Hosts the first federally funded National Adult Protective Services Training Center providing foundational elearning courses at no cost to APS nationwide.
- Hosts an annual conference and a national summit on financial exploitation featuring nationally known and respected professionals who share their expertise on innovative issues applicable to APS practice and other disciplines. Hosts an annual World Elder Abuse Awareness Day event focused on financial exploitation.
- Serves as the national voice for APS and works to increase national awareness of older adults and persons with disabilities experiencing maltreatment through education, advocacy, and congressional testimony. Through NAPSA's advocacy APS received the first federal funding directly for APS operations in 2021.

What is Adult Protective Services?

Adult Protective Services (APS) is a social services program provided by state and local governments nationwide serving older adults and adults with disabilities who are victims of abuse, neglect, self-neglect, and exploitation. APS workers frequently serve as first responders in cases of abuse, neglect or exploitation, working closely with a wide variety of allied professionals such as physicians, nurses, paramedics, firefighters and law enforcement officers.

How APS Helps

Most older adults and adults with disabilities live independently without assistance, however, some face abuse or neglect by others and need trained professionals to support them. Others may simply be struggling with routine activities and benefit from in-home support services to maintain their health and independence. APS helps by investigating reports, assessing each individual's unique strengths and needs, then developing a service plan to maintain their safety, health, and independence to the fullest extent possible.

DEVELOPMENT

In carrying out its responsibilities, the Development Committee: Identifies potential sources of funding for NAPSA; Cultivates relationships with potential and current funders; Solicits sponsorships for the conference and the EFE summit; and recommends new fundraising strategies to the board.

DIVERSITY, EQUITY, AND INCLUSION

NAPSA's Diversity, Equity, and Inclusion, Committee is committed to and focuses on providing guidance and supporting APS programs to develop, implement and promote diversity, equity, and inclusion and all levels of APS work.

EDUCATION

The NAPSA Education Committee serves to emphasize the development of increased skills, knowledge, and abilities of APS professionals by developing and disseminating training materials for APS and allied professionals. Some of the accomplishments of the Committee include working with ACL to utilize the NAPSA APS Program Standards as a building block for developing a national standard; converting all the NAPSA Modules from on-line into classroom instruction; and developing a national APS training survey.

ETHICS

The NAPSA Ethics Committee serves to support APS professionals to work in ways that meet the ethical standards of the profession. The committee works to provide information and guidance to the APS network about how to practically implement ethical standards at every level of practice.

MEMBERSHIP

The goals of the Membership Committee are to expand NAPSA membership, identify unaddressed needs of current members and increase involvement with NAPSA by developing an inclusive volunteer recruitment, training, support, and recognition program. Some of the projects the Committee has worked on include the development of a welcome video for new members and a volunteer and staff recognition program. New ideas and perspectives for increasing and maintaining membership are always welcome!

PUBLIC POLICY

The Public Policy Committee advocates on issues and legislation affecting the abuse, neglect, and exploitation of vulnerable adults and other related issues germane to adult protective services programs across the country and in the territories. Most of the committee's energy has recently been focused on the renewal of the Elder Justice Act (EJA) and the protection of the Social Service Block Grant (SSBG).

NAPSA RESEARCH TO PRACTICE INTEREST GROUP

The NAPSA Research to Practice Interest Group is a unique effort to encourage the linkage between research and practice in the field of elder and vulnerable adult abuse. The committee welcomes both practitioners and researchers.
